7. Emergency Agreements of Transporter & Owner

A. In the event the animal(s) require the services of a veterinarian, RRS will attempt to notify the Owner. In the event the Owner cannot be reached, the Transporter is hereby authorized, as agent for the Owner to call the first available licensed Veterinarian of RRS's choice. All fees charged by said Veterinarian shall be the sole and exclusive responsibility of the Owner, with no liability whatsoever to RRS for such fees.

B. If the Owner is unreachable and RRS bears the initial cost of the above-described service in subsection (A), Owner agrees to reimburse RRS for all veterinary services, drugs and other medical supplies in the event of an emergency or as RRS deems necessary for the well-being of the aforementioned animal(s). These fees are to be paid in full before the animal(s) are unloaded.

8. Release and Waiver of Liability, Indemnification

Owner agrees, promises and covenants not to sue, assert or otherwise maintain or assert any claims against RRS or its agents or employees, for any injury, death, disease, or damage to the aforementioned animal(s) arising from or in connection with RRS's transport, care or feeding of said animal(s) or from any claims asserted by other third parties in connection with RRS's transport of the animal(s).

Owner further releases, waives, discharges, and covenants not to sue, RRS, nor any of its elected and appointed officials, employees, officers, agents, successors, assignees, and volunteers regarding any and all claims arising as a result of RRS's transport of the aforementioned animal(s).

To the fullest extent permitted by law, Owner shall indemnify, defend, and hold harmless RRS, its elected and appointed officials, employees, officers, agents, successors, assignees, and volunteers from any and all claims, lawsuits, losses, and liability arising out of RRS's transport of the aforementioned animal(s). Further, RRS does not waive its Governmental/Sovereign Immunity by executing or entering into this Waiver and specifically retains all immunities and defenses available to it as a governmental entity pursuant to WYO. STAT. ANN. § 1-39-101, et seq., and all other applicable laws.

9. Entire Agreement

Owner understands that this is the entire agreement between Owner and RRS, its agents or employees, and it supersedes and cannot be modified or changed in any way the representations or statements of any agent or employee of RRS or Owner.
